6. What feedback would you like to share about the Task Force's recommendations or what should City Council do next?

1 Springfield is a beautiful place to live, filled with a vibrant population. We must not compromise any factor that plays into the well being of our city. We must create new strategies to ethically celebrate our strengths while generating income. In other words, more, not less. 2 Why would the library, the smallest division, have to take the lion's share of cuts? During Covid the library was open to serve our community while the other departments remained working from home, away from the public, for months if not years. How much could we save by not printing City of Springfield on thousands of pieces of plastic crap? 3 do not raise or do levy on my property taxes. they are too high already 4 Why is the library the only city service getting cut? Surely there is streamlining to be done in other departments. I'm tired of the knee-jerk "cost cutting" response to these sorts of problems. 5 6 More budget reductions should have been made this year 7 The report mentioned citizen education about the issues and relegated it to the small dues-required, private circles of City Club and Chamber. And yet what is the only City entity that is actually involved in education and accessible to every resident from birth to death? The library. The library is an essential service that works in tandem with the other services. Can't you imagine that public safety expenses will increase with decreases in library services? and vice versa? The library services are already rather minimal and diluted further by adding the expense of a museum to it with no particular plan in place. For cutting costs, I recommend looking at administration expenses and considering, for example, eliminating some HR FTEs. For raising money, why not create a public safety foundation similar to the Springfield Education and Library foundations? I expect adopt-a-police-dog fundraising would be popular. Are we still renting jail space to Eugene? And the car property tax idea for roads, bridges etc. is a great idea that wasn't really communicated and explained to the residents and had high-powered people like the local chamber director opposed such that endorsements came out as lukewarm at best. I've lived in two different states that had car property taxes. It works. And a payroll tax for larger for-profit and government entities means that those who work in Springfield and benefit regularly from city services even though they might not live here, are also contributing. 8 The budget shortfall is serious and I understand the need for cuts. However, I think slashing such a huge percent of the library's budget is misquided and will disproportionally harm low-income residents, children, and parents. The library was a lifeline for me when I was a lonely new parent, providing a safe place to meet other parents and provide my baby early socialization opportunities. It remains a favorite place of my now 10-year-old's, and Saturday hours ensure that as a working parent, I can keep up with her voracious reading habit with a weekly trip. The drastic funding cuts proposed to the library would undoubtedly reduce hours, making it harder for working parents like me to take their kids to the library, and would likely reduce staffing such that programs like baby, toddler, and bilingual story times may disappear. I simply cannot stress how important these are to new parents and young kids, especially those without family/social support who feel isolated. The

cultural programming supported by the library has also been a mainstay of my family's life and has given us many opportunities to learn about and appreciate art, history, and traditions outside our

lived experience. It would be a tragedy to lose these opportunities in our hometown, which foster understanding, communication, respect, and relationship building that makes the community stronger. It was also because of the time I spent at the library that I became aware of the Springfield Arts Commission, applied, and served for 8 yrs. In doing so, I became more civically involved than I have ever been. I built relationships and collaborated with people I otherwise wouldn't have met, and had the opportunity to support the cultural life of the city through programs such as the mural walks, Second Friday Art Walk, and Heritage Arts Grant-funded events such as the MLK celebration, Noche Cultural, Eugene-Springfield Youth Orchestra concerts for Springfield students, and countless other public events. It saddens me to think that the library may soon lose the staff or funding needed to support something that I saw do so much good in the community. In addition to all of this are the many other services and programs the library offers that benefit the community. When the ice storm blew my internet out for 10 days, I was able to work in the library. Nearly every time I go, I see adults at the computers who may not otherwise have access to resources to create a resume or search for a job. I watched an exchange between a librarian an an unhoused man who was nearly brought to tears when she treated him like every other patron and kindly let him know he could still check out books and use the computers without a permanent address. And my child is never the only one spending hours in the stacks finding books for research projects and pleasure. In short, the library gives so much to so many people in our city. There are so few "third places" like it that offer physical space and resources to anyone who wants to access them, without requiring a purchase of some kind; so few that offer free children's programming to ensure kiddos from babies to teens have a safe space to explore, learn, and socialize. For those who have never used these things or those who can afford other recreational activities or tutoring services or camps, this may seem like a small thing. But it's not - it's hugely impactful to many whose lives would shrink with the loss of library services. And in a city in which schools are underperforming and housing costs are rising, the likely reduction in cultural programming, resources, and family-friendly activities that would result from cutting more than a fifth of the library's budget will make our city less likely to attract the very kind of investment it needs to grow and sustain itself. Please, look for ways to make smaller cuts to more budget areas that can be dealt with, rather than devastate the library with a single huge cut.

- **9** Try to keep the library accessible as much as possible with safety precautions to the public
- Springfield is a very business friendly town---opportunities (tax beaks) are offered to businesses it makes sense that with opportunity comes downstream costs ---in the form of a payroll tax. Having a payroll tax that has parity with Eugene also makes sense. Proposing a levy as a solution to funding the library given current compression is not viable and hurts the people in our community trying to improve themselves.
- 11 Cost cutting should be across the board, not just the library. It has vital services that assist our community. Cutting budget means cutting staff and hours when it's already quite limited in hours. As a working parent, my kids want increased hours on the nights and weekends at the library, not decreased hours.
- I was impressed by the informed conversations about the payroll tax, and feel it was the best fair option for increasing income to deal with budget shortfall. I thank City Council members and Task Force for their public service, intelligent comments and questions, and countless hours they put in for the citizens of Springfield.

14 I believe that it is unwise to decrease library costs. Library hours are already very limited making it hard for the community, including my family, to use a valuable and free resource. New sources of revenue and economic development are some of the best options because these solutions will be helpful in the long run. 15 Save the library 16 Please reconsider cutting funding to the library. If you must, consider reducing the amount cut, and put forth a levy to have it re-funded. 17 I am strongly against such a major cut to the library budget. This is the worst time in history to reduce public access to early literacy and learning opportunities. Public education is under attack across the country and access to higher learning is reserved more and more for wealthy individuals only. Additionally, libraries are generally one of the few remaining accessible spaces where community members can meet and connect for free. Keeping the library funded is a crucial way we can preserve educational opportunities for all and a deep sense of community for Springfield. 18 Cutting the library's budget will have a huge impact, getting families, teens, and the most vulnerable in our community. The library is an important part of Springfield and provides, help, services and a "third place" that are so vital in our modern world. The amount proposed could be easily covered by a payroll tax. Those who live in Springfield and work in Eugene are already paying a payroll tax to support Eugene. It is only fair that we ask those who live in Eugene and work in Springfield to pay a similar tax to support Springfield. 19 Have the liberary open between 3pm-7pm. 20 If the Library has an additional 17,000 more readers than before why would you think that decreasing the Library's budget would help. No, that number should be reduced by a lot. A lot of people myself included are avid readers. I love my kindle and I read a lot and enjoy the summer reading program a lot. I volunteered at the Library for 11 years and I still volunteer when I can. 21 The deficit issues cannot be fixed only by one solution - cuts or new revenue - alone. I agree with the Task Force's recommendation to approach the problem from multiple angles at once. Solutions that are less administratively burdensome to implement seem to have the most potential. I think Springfield doesn't need to be boxed in by what we have always done, but we also don't want to be creative for creativity's sake. I like the focus on long-term solutions that are sustainable. 22 -Reducing police overtime, the analysis and discussion doesn't present any realistic or reasonable way to actually do this. Reducing overtime would absolutely degrade services, so the statement that "it must be done without reducing staffing or service levels" really doesn't make any sense. The only way this could realistically be done would be to increase FTE so that the same workload is being spread across more employees. However as you increase FTE there is an additional burden (insurance, benefits, etc) so that would offset any savings in reducing overtime. So overall this proposal doesn't make much sense to me. -Gateway UGB is problematic because it would require substantial infrastructure improvements to roadways in particular the Gateway/Beltline intersection. The costs associated with the significant infrastructure upgrades would be exorbitant and would not be fully funded by development. -Traffic cameras are a highly contentious and problematic issue. The proposal explicitly states that these cameras should not be used as a revenue generator, so it really has no place at all in a budgetary discussion. If it should not be used as a revenue generator then why

	are we even talking about it? This concept goes against Springfield core values in many ways. There is also evidence that it does not increase safety and in some ways can be detrimental to safety. This proposal was made without any input or consultation from Springfield Traffic Engineering staff and I suspect you'd experience strong resistance from both staff and the communityThe library is a service utilized by disadvantaged persons (i.e. without computer/internet access, for example) and this is a minority of the population but it is extremely important for that small group. I think if you collected community input you might find that it is underutilized by the majority of the population, which might make you think it is less important than it really is. It's kind of like the bus system, in that it operates at a loss (intentionally) to provide a critical service to those vulnerable populations. So I would urge you to not simply coallate the community feedback and base your decision off how the majority of residents use itWas an analysis of a Transportation Utility Fee explored? The report indicates that this fee is utilized by many other communities and can help offset reduced timber receipts and reduced gas taxesWas analysis of a local gas tax explored? I don't know if this is possible but Eugene for example has a \$0.03 gas tax. We should add a gas tax that equals Eugene's.

81	I am new to the area. The presentation was thoughtful, explained well with background detail and easy to understand.
82	We need to focus on fixing our broken tax laws in Oregon and finding other sustainable sources of income for our city. Gutting our already underfunded public services will only worsen our problems and make Springfield a less desirable place to live.
83	I am firmly against cutting the library budget. This is a place where people go for resources, warmth, cool, peace, safety, kindness, community. Of all the services my taxes fund, the library is right up there at the top. If people need to find information, look for jobs, do their school work, do research for projects, get connected to servicesthey do it all at the library. Public safety represents 73% of the city's General Fund expenditures and the library only represents 5%. Why in the world would you choose to cut \$500,000 from the library instead of other places makes zero sense to me. Please leave

	the library alone and look for other places to trim the budget or generate revenue and economic development. Cutting services from our most vulnerable is NOT the way to build a community or balance a budget!
84	Hands off our library!!! The library provides essential serviceseducation, internet access, community news, entertainment, etcespecially to low income citizens of our community.
85	Save the library budget! Libraries are very important to the well being and education of everyone.
86	Consider reigning in public safety expenses before reducing budgets of community resources like the library. Kicking the can down the road seldom solves budget imbalances.
87	I am extremely concerned with the plan to utilize traffic cameras. This technology is problematic for everyday citizens' privacy and has significant constitutional concerns. No to Flock Cameras! I am also highly concerned about the recommendation to cut the library funding. The library is the heart and soul of our community. There is scientific data that libraries in fact reduce crime. Cutting staffing, hours and programs appear counterproductive to one of the overarching goals of reducing crime/improving public safety.
88	Why are we considering spending money on surveillance cameras when we're cutting other basic services that can actually deter crime (such as access to a public library where there are resources to find jobs, provide recreational opportunities, and further educational goals). Instead, the task force recommendation is the creation of a police state that sets the table for a future stripping away of civil rights?
89	It is harsh to reduce the library budget by \$500,000. It serves vital services and provides culture, education, and much more value for Springfield.
90	No cameras
91	As Springfield's senior population continues to grow, we must reevaluate the long-term sustainability of property tax exemptions for older residents. While these exemptions were designed to support seniors on fixed incomes, they now risk disproportionately reducing the funding available for vital public services—especially schools, libraries, and parks that serve all generations. Rather than blanket exemptions, the city should explore more equitable models that preserve support for vulnerable seniors while ensuring that our shared civic infrastructure remains strong and well-funded.
92	Library is an important part of this community
93	With the newly updated library and it's ability to share information and bring our community together, I believe it should be a last resort option to cut its funding. With controversy around collecting personal information and even the usefulness of cameras, I believe the implementation of traffic cameras should not be considered.
94	You say you'll just cut the library by \$500,000 without describing whatsoever what kind of impact that would have on those services. Like it's too bad to even describe
95	The library services should remain commiserate with other same size cities like Corvallis. Spending money on cameras at this time seems irresponsible.
96	The library is a good resource for the community because it has the level of funding it does. Decreasing funding would decrease quality of service and services available. Springfield needs a

strong library, which means fully staffing it and keeping a book and program budget, with at least current hours or more. 97 Please do not cut the library's budget at all! If you absolutely must, please do so as little as possible. This city is littered with vacant buildings - do something about that! Sell or develop city owned properties. Consider a vacancy tax or an initiative for property owners to fill their vacant buildings. Support SMALL business development (and when I say small, I truly mean tiny businesses), including finding a way to make commercial rent more affordable for small startups. Addressing the many vacant commercial properties and supporting SMALL business development will make this a more attractive place to live. Work with other towns facing budget challenges to address Oregon's property tax limitations so that this doesn't continue to be a problem for us and many other areas for decades to come. Reduce police spending and focus on other solutions that improve public health and reduce crime. And don't you dare install those Flock cameras! 98 I am incensed that the task force only valued input from business people. They're not the only people who understand economics and finances. That is an insulting viewpoint. I am further incensed that most of them don't even live in Springfield and neither does your consultant. It absolutely matters. When the proportionally biggest cut is to a city institution it matters if the people recommending that even live here. Also please don't lie and say the library hasn't experienced any cuts and if other departments have experienced cuts give us a percentage. Was it 25% like the proposed library cut?? 99 The police don't need anymore money and the library needs all it can get. It's eye-opening and embarrassing to realize how little I know about the rest of the recommendations, but I know enough to know that much is obvious. 100 Library - I do not support cutting the library budget, but if it continues to be included as a recommendation, I recommend adding stronger language around a library (or maybe an arts and culture to include the museum) levy or potentially a special district like Willamalane. If possible, I also recommend spreading cuts out over multiple years. Traffic Cameras - I don't think it's appropriate to include things that likely wouldn't have a revenue impact in a report focused on revenue generating. My understanding is that, if done correctly, including citations being reviewed by a law enforcement officer and associated administrative expenses, Cities are lucky if cameras are cost neutral. Plus the hope is that any revenue declines over time as people drive more safely. The line in the report that says Cities contract with vendors so there are few upfront costs is confusing - there is an ongoing cost, correct? The report makes it sound kind of like a freemium marketing scheme and reminds me of the adage - "if you're not paying for something, you're the product". This recommendation also comes at a time for increased worry about government surveillance and especially federal law enforcement. Including it and potentially moving forward at this time is tone deaf when so many community members are already living with so much fear. At a minimum this report should include a recommendation to set up a separate tax force specifically to review automated enforcement options that minimize surveillance (such as only taking a photo when a violation is detected, and having very limited intersections so that people cannot be tracked), and also analyze for potential disproportionate impacts of an automated system and selected locations. 101 We need to find other sources than property taxes to fund. 102 Please don't cut library funding. They provide so many invaluable and irreplaceable services to so many in our community, and we would be much poorer without them!

103	None at this time
104	Start by cutting services that are rather antiquated and being covered by other services. The Library is the #1 thing here, most people have a pocket computer that can access all the books, we have Willamalane and private business, as well as school clubs for after school and youth activities.
105	Please do not cut the library budget. It is vital to our community. I would be extremely upset to see library services or staff diminished.
106	No red light cameras. Develop a strategy to protect immigrants from ICE. Reduce jail budget.
107	I would avoid cost-cutting police/fire safety and library services. Our city attracts visitors, residents, and businesses especially because it is safe, has excellent educational, recreational, and city library/museum services, which provide access to very much needed help, information, literature, cultural, self-improvement opportunities for all citizens and visitors in Springfield.
108	Listen to your constituents
109	the selling of city owned properties should produce the most effective relief to the tax deficit of Springfield. Decreasing the Library Budget should not be considered, as it is too important to leave that intact or increase that budget. Selling the city owned properties and looking at developing the Gateway Properties is much more desirable. I do not want more cameras on license plates, that is heading more towards, becoming a police state, monitoring our movements.
110	Implementing shared payroll tax is a burden on employees. It raises funds inequitably. Implementing traffic cameras is a sin tax. Regressive and ineffective. We need to reduce our Public Safety budget, not increase it. Our library is what makes our city a community. Please don't defund it.
111	The task force needs to consider civic development - this isn't a business it's a community
112	The council should adopt the task force's recommendations, but that will only buy time - it does not address the structural deficit the city and virtually all other taxing jurisdictions in Oregon face to fund public services. Nor does the task force's work address the substantial financial issue of deferred maintenance costs on city-owned property and infrastructure. The council should continue to reach out to Springfield residents, business owners and employees to prioritize public services and funding. Springfield voters have supported the public safety levy to fund police and jail operations by wide margins. Perhaps voters would also support an operating levy for the library as well. But Springfielders need to determine - and fund with their hard-earned dollars - what services should and can be funded within the bounds of available resources.
113	The task force was not representative of actual Springfield residents and didn't even consider folks with fiscal stability know how who aren't 'big business' folks. 115 The library seems to cater more towards minorities in the area (Hispanic folks predominantly) and isn't reflective of the ACTUAL demographic in Springfield. All the signs are in Spanish, and it really just seems like the working class people of Springfield are not included, even though they are the dominant demographic. It feels like the library isn't for us, because it's so focused on Spanishlanguage this, and LGBT-that. So, you're not going to see people wanting to go in there. It's not welcoming to the majority demographic of the area, so it just doesn't get used. SEDA's inventory is expansive and most buildings appear to sit vacant. What good is it doing Springfield for SEDA to continue purchasing and sitting on buildings for future development? It seems like it's costing money, not making any. Are there buyers out there who could buy and develop these buildings? FLOCK cameras and reducing police overtime are not an adequate reaction to generate revenue. I would take a payroll tax before I would ever reduce the police OT or add those privacy invading cameras. The answer also isn't to try and penalize your citizenship into fixing the budget gap with red light cameras. 116 The Task Force is not even wholly made of Springfield residents and they vastly represent the business owner and executive community. If you wanted to know what Springfielders want you would have selected a more balanced Task Force. The City and the Chamber of Commerce have a solution in mind and have a deaf ear to true public feedback. 117 Don't cut library hours. A broad cross-section of our community depends on the library, which already runs on a less-than-ideal schedule. 118 Do not cut from the library. It provides refuge, necessary services, education, activities, and entertainment. We have lost so much to the wealthy and greedy. Don't take this from us. 119 The suggested payroll tax is too small and should be increased to cover the possible cuts from the library. As a self-employed individual I pay double in these employer-employee tax pay-ins. I'm fairly certain 120 that many (most?) self-employed individuals feel the burden of this arrangement. This situation apparently began over a decade ago with caps on property tax increases and with 121 reduced timber revenue. Slashing the library budget won't provide a long-term solution and will create hardship for many members of the community that use library services. Fines resulting from traffic cameras are unlikely to generate enough revenue to significantly impact the budget shortfall. The City Council needs to pursue practical and systemic changes beginning with selling or developing unused properties, expanding business opportunities, minimizing tax breaks used as incentives to large businesses, and fully staffing the police force so overtime is rarely necessary... 122 Why isn't the city considering spreading cuts across the departments. I know the city budget is always tight, but saving the budget by severely cutting the library is a poor choice. Your gutting of fire and ambulance service is irresponsible and needs to stop. We are constantly 123 running short of needed fire response and are out of ambulances because of your decisions. Public safety should be the highest priority, both fire, ems and police.

- **4** A city without art or books is not somewhere I want to live. People should embrace paying more for what they value. Taxes make that happen.
- There are so many unused spaces within the city limits that could be developed and make Springfield look and feel better. Let's find ways to use them!
- Is the transient lodging tax lumped in with the tax revenues? What was the percentage going to tourism in 2003?
- **7** For reference, I'm a resident of Ward 3.
- **8** When will all of these cuts be happening and will the public be informed? What ways can the community stay involved to let our voice be heard?
- **9** Invest in Springfield and its residents by finding new revenue streams, not cutting services: police, fire, library.
- While I appreciate the effort to reduce costs and increase revenue, this current plan feels short sighted in its impact on our community. As a community member, please do not cut the library's funding!!
- 11 I proudly retired from teaching at elementary level in Springfield after over 35 years serving this community and its children. Reading is the great equalizer, and the library is a fantastic resource for all members of the Springfield community. So many children are unable to afford the materials necessary for success in life. I was always overjoyed to be able to share the books I had checked out, and to hear students brag about their library cards, books and library visits. I also want to compliment the librarians on their helpfulness, skills, and friendliness. Please do not diminish Springfield's ability to reach all its citizens by severely cutting funds to the library and its excellent programs.
- **12** Don't cut library funds
- 13 The library is a needed community resource. Cutting costs in different organizations, including those outside of the library, are short term solutions that won't help our community in the long run. Working together to find good ways to increase revenue is one of many other options that can be used.

- **14** Don't cut library funds or staff
- 15 I'm disappointed and frustrated about the choice to cut funds for the library. Failing literacy rates negatively affect every level of society, and the work the library does to educate and engage the community should not be under-valued.
- We need creative solutions to this complex problem. Cutting the library budget significantly might feel like an easy way to save some money, but access to public library resources is an upstream solution to crime and poverty. Cutting the library budget now will cost the city more money in the long run.
- 17 I believe state tax reform is necessary and the best solution, but will not occur quickly enough to remedy the current shortfall. A payroll tax is the best immediate option that spreads the burden fairly across demographics and income levels. Those who work in Springfield use Springfield services and should help pay for them, even if they live elsewhere.
- **18** Have the liberary open between 3pm-7pm.
- 19 Traffic cameras cost a lot of money. There are enough cameras around town. Everywhere I go in Springfield people are speeding. How about having one or two officers per day out getting money through tickets. It is downright dangerous on Pioneer Parkway West and Harlow Road. Particularly from 6:30 am to 8:30 am.
- The Budget Committee should be empowered to dive into specifics of the task force recommendations and how they relate to fiscal policy. It seems like the Budget Committee has been hamstrung recently to not be able to look at "policy issues," but I think that's the most appropriate place to get stakeholder input on policies that impact fiscal health of the City going forward. I would like to see the Budget Committee have the opportunity to provide more meaningful engagement to advise the Council on policy matters.
- 21 I know it's hard to make choices that won't be popular with everyone, and I know Springfield has a lot of squeaky wheels and even squeaky businesses. I applaud you for getting out ahead of this. - Adopting a budget that includes fire station brown outs within days of two fatal home fires in Springfield feels unspeakable. We need to stabilize funding for the fire service in Springfield, and the best way forward to do that is the establishment of a fire district.
- **23** Tired of the City not prioritizing safety.
- 24 It is deeply concerning that the Fiscal Stability Task Force was not allowed to consider the fire governance options outlined in the taxpayer-funded feasibility study for Eugene Springfield Fire. Restricting this discussion undermines public trust in the City's leadership and prevented the task force from exploring one of the most fiscally impactful options available. Equally troubling is the City's decision to approve fire station brownouts with minimal discussion or understanding of the consequences. These actions do not inspire confidence in the City's ability to sustainably provide fire and EMS services. The most prudent and responsible step forward is to seriously consider

- Why are you not considering fully funding emergency services? It is deeply concerning that the Fiscal Stability Task Force was not allowed to consider the fire governance options outlined in the taxpayer-funded feasibility study for Eugene Springfield Fire. Restricting this discussion undermines public trust in the City's leadership and prevented the task force from exploring one of the most fiscally impactful options available. Equally troubling is the City's decision to approve fire station brownouts with minimal discussion or understanding of the consequences. These actions do not inspire confidence in the City's ability to sustainably provide fire and EMS services. - 33 I relocated to the area from out of state, and make low six figures. Springfield lacks housing supply and needs to focus on increasing the supply. Next focus on economic development, Springfield should be the shining beacon in the area and not Eugene.
- Our library has been underfunded and defunded for decades. It's budget is tiny compared to the police and has never incurred a single lawsuit or caused the city's insurance to be raised higher and higher. The mayor and councilors need to be brave enough to hold the police accountable for their budget missteps, not take it out on the library because it's the easy way out.

- 42 How much does police overtime add to the budget? Why is this happening?
- Our cops have a proven track record of costing the community in payouts for their malfeasance. Then library only enhances the community. Don't take it out on them. Protect the library. Kids around here have it tough enough.
- Decrease homeless damage to business fronts by creating a tiny home camp or parking area out near the dump.

- **62** Thank you for NOT cutting the library budget.

- 67 I understand the budget issues are real and complicated and I appreciate you listening to our concerns. Please recognize how important the library is for the well-being of our Springfield community.
- Mayor VanGordon, next time you create a task force, make it more diverse and equitable. Stop putting large business interests over the actual residents of this town.
- **69** People think very highly of the library and often times that high regard gets extended to city leadership as a whole. You're squandering that good will. I am more than happy to pay a slightly

higher payroll tax to avoid cuts to the library and I am insulted that business and city leaders would pretend keeping the payroll tax low is about protecting me - the average Springfield citizen. Bullshit.

- **70** Underlying tax reform is the cleanest and most sustainable solution. The budget problem is clearly on the revenue side of the budget.
- 71 It doesn't look like the City analyzed the possibility of a Sugar Sweetened Beverage tax or fee or potentially increasing fees/taxes/licensing costs for tobacco retailers. Please consider these.
- 72 The library is a lifeline in the community. Cutting the library budget should be a last resort.
- 73 Selling unused properties is a top tier idea. It gets the maintenance costs off the tax payers, gets an immediate influx of cash on the sale, then collects property taxes ongoing, assuming only sale to private parties rather than non-profits or other government agencies.
- 74 There are so many community members who are kit on social media. Putting something on facebook is not sufficient. For those of us who do not work flexible hours or have young families, a couple days notice is not sufficient to get time off work and attend town hall meetings
- Hiring more police will increase overtime as arrests will increase and out of regular work time tasks such as going to court, booking late in day, etc. will increase. Decrease overtime by laying off police. Look at Vera Institute report on effects of expanding jails in small towns.
- Please do not cut any fire or police services or their overtime as a first or even middle choice for cuts. Those public protection services cannot be constrained into a 9 5 time-frame. The situations they deal with don't happen always within office hours, whether it's a sudden brush or house fire or someone invading a business or residence. Insurance companies also tend to shy away from covering areas with limited access to good police and fire protection.
- How many of the Task Force Members have and regularly use Springfield Library Cards? How many of the City Council Members have, and regularly use Springfield Library Cards. Those that do not, should not be able to vote on this singular issue.
- **78** Would a business retention and expansion strategy place an emphasis on attracting and supporting independently owned businesses?
- Just as the task force was charged with having everything on the table, the mayor, council and staff should take a further look with their counterparts in Eugene and Lane County to determine if there is a better, more cost-effective way to deliver police, fire, jail, other public safety and library services, and even consider changes to governance. If we can and should think big about how public services are funded, we should likewise challenge ourselves with at least contemplating changes in how we govern this metropolitan area. We are one economic market, and just because I-5 helps to separate jurisdictional boundaries doesn't mean there isn't a better way to govern ourselves.
- 80 The mayor claimed crime went down in Springfield because of the jail being built. But crime went down everywhere in Oregon (and has been trending downwards nationally for decades) over the same time period. Even though only one other city runs a jail. Getting honest about what our police force and jail costs seems to be political kryptonite in this town but just know that we see you refusing to discuss the police budget.

- 81 Stick with what the residents of Springfield say they really want, and what they could do without.
- **82** Please make sure you are not falling prey to the idea that there needs to be unequal emphasis on minority groups when you make these decisions. Look at the actual demographics of Springfield and do what's right by ALL of them.
- Why don't you select a random group of Springfield citizens to evaluate your options? Secondly, I have been hearing about the budget crisis since Mayor Lundberg and City Manager Grimaldi. The City Council, Mayor, and City Leadership are largely responsible for kicking the can down the road for years and now announcing a crisis. Thirdly, the Task Force does not even suggest a sustainable path forward that gets the city out of a deficit. Why don't you propose solutions that actually get the city out of a deficit instead of these half measures? Are you hoping for a miracle or for the current leadership to be gone by the next crisis?
- **84** Please be serious when considering police OT with the union. This is a touchy issue but boundaries should be set.
- **85** Let's not spend a ton on blue LED street lights that pollute our homes of circadian rhythm. Not contract with Flock cameras invading residential privacy. And let's contract with more efficient contract contractors who aren't taking a full year to do one street Mill St. and the underlying infrastructure that is ridiculous. In any other state that street would be done and the water and sewer would be complete in two months.
- **86** We don't need more law enforcement we need affordable housing, housing for the homeless, landlords to stop raising prices, a cap on rent, employment, and taxing the wealthy.
- 87 If the City of Springfield offers tax breaks to national corporations that want to set up shop and do business here, that needs to stop. If Springfield is that attractive to them, they should pay their fair share (if not a premium) for the privilege of gaining profits from Springfield citizens.
- 88 I appreciate the opportunity to voice my concerns and opinions. I hope the Mayor and City Councilor seriously consider the feedback they receive from community members.
- **89** The library tracks the interacts it has with patrons. How many other departments (aside from police and fire) have as much interaction with the public?
